GUIDANCE NOTES TO CONSIGNORS

- **Food Chain Declaration:** At prime stock and cull cattle sales a Food Chain Declaration **MUST** accompany all livestock to market. All classes of store stock, including feeding cows and sheep should be accompanied by a Food Chain Declaration as this is required for the trading of forward conditioned animals, some of which may be short keep. This is important for animals which have been in the producer's care for a short period, particularly in relation to withdrawal periods for veterinary medicines.

All our movement documents have also been modified to accommodate this and allow us to pass on medicine withdrawal information when required.

- **Farm Assurance:** Animals offered for sale as Scotch Potentially Eligible (**SPE**) are warranted by the vendor as having complied with QMS Certification Standards including being born and reared on farm assured holdings in Scotland.

Animals sold as Farm Assured (**FA**) are only warranted by the vendor as being offered for sale from a Farm Assured Holding.

- **Passports:** All movements on behalf of vendor and purchaser will be notified electronically to BCMS by the Market under the General Licence. Do not duplicate the notifications to BCMS electronically with your own IT System. Please ensure that this completed and signed Movement Document together with the relevant passports travel with the animals to market.

Remember all passports must be signed and dated.
